

Palantir Payroll Toolkit:

Tell Congress, Stop Taking Money from ICE's Top Corporate Collaborator

Background:

One of ICE's top corporate collaborators and tech enablers is Palantir Technologies, a multi billion dollar surveillance company run by far right billionaire Peter Thiel and Alex Karp. Palantir [donates MILLIONS](#) in political donations to Congress, and receives BILLIONS in federal contracts. Palantir's tech [helps ICE track](#), abduct and arrest people. It's time to tell Congress to take the pledge - no dirty Palantir money!

We have launched the Palantir Payroll - a [donation tracker](#) that reveals which Democrats and Republicans that receive Palantir donations. Check out the [full list here](#).

Here's what you can do:

1. Send the email blast below to your list to encourage them to reach out to their members of congress and tell them to stop taking dirty Palantir money.
 - o Members of congress who currently take Palantir money should donate it now to veterans or immigrant serving organizations
 - o All members of Congress and candidates for congress should sign the pledge to stop taking Palantir money
2. Send an organizational email to your member of Congress
3. Host an action or office visit to your member of Congress to urge them to sign the pledge.
4. Share out social media on your channels to urge people to take action!

Palantir Technologies is a software company, co-founded by Peter Thiel and Alex Karp, that builds AI-powered tools for mass data collection and mass surveillance. This company, fueled by taxpayer dollars, poses a fundamental threat to individual privacy and liberty, our democracy, and our constitution. This is well-documented, with our distilled reasoning below.

- **Privacy and Government Overreach:** Palantir software has been used by DOGE in their [reported attempts](#) to integrate [sensitive data](#) on Americans across government agencies. Already, federal law enforcement officers are using [a Palantir software called ELITE](#) that compiles data from various government and private sources to identify "potential targets" based on what neighborhood they may live in. It is well documented across many cases that law enforcement that is using this software has also apprehended US citizens, legal migrants, and other US residents without due process, in violation of the constitution. Merging data across agencies poses serious privacy and surveillance risks for all Americans.
- **Security Risks to Classified Information:** According to a [September 2025 U.S. Army memo](#), a battlefield communication system developed by Palantir and Anduril contains deep flaws that create security vulnerabilities that make the system "very high risk." We should not be relying on software that puts any of our servicemen and women, or our country, at unnecessary risk.
- **Profiteering off American Taxpayers:** Palantir has secured more than [\\$900 million in federal contracts](#) in 2025 and has brought in over [\\$2.5 billion in federal contracts since 2009](#). Palantir's Foundry platform is being used by at least four federal agencies. In May 2025 it was reported that [Palantir was already in](#)

[contract talks with both the Social Security Administration and the IRS](#). Palantir has done this in part by [aggressively recruiting former government officials](#), including people from the White House, Defense Department, CIA, and Congress. In addition, Palantir technology is [fueling the foreign wars that American taxpayers are paying for](#).

For the reasons mentioned above, we the undersigned Members of Congress and candidates for federal office, reject any and all campaign contributions from Palantir Technologies, its PAC, and any C-Suite Palantir employees.
