

THE PALANTIR PAYROLL: METHODOLOGY AND LIST OF EXECUTIVE DONATIONS

Source: Original analysis of Federal Election Commission (FEC) data by the Purge Palantir campaign.

Methodology: Totals on the Palantir Payroll website reflect itemized contributions (including those allocated from joint fundraising committees) received by principal campaign committees, leadership PACs, and single-candidate super PACs. Analysis includes contributions from 2006 through the most recent available FEC filings as of January 20, 2026.

The universe of donors consists of Palantir's corporate PAC (Employees of Palantir Technologies Inc. PAC) and all individual contributors who have their employer listed as Palantir on FEC filings.
