Methodology: Totals reflect itemized contributions received by principal campaign committees, leadership PACs, and single-candidate super PACs. Analysis includes all contributions made by Peter Thiel from 2006 through the most recent available FEC filings as of August 5, 2026.

We classify the following super PACs as single-candidate super PACs and assign donations to candidates accordingly: Saving Arizona PAC (Blake Masters), Protect Ohio Values PAC (JD Vance), Endorse Liberty Inc. (Ron Paul), Revolution PAC (Ron Paul), Free Forever PAC (Kris Kobach), CARLY for America (Carly Fiorina), and Fighting for Ohio Fund (Rob Portman).

Note: The \$49 million total on the Palantir Payroll page reflects all of Thiel's political donations. The donations listed below (which collectively sum to \$43 million) include only contributions tied to specific candidates — through their campaign committees, their leadership PACs, or through single-candidate super PACs. The remaining \$6 million went to entities that support multiple candidates or aren't tied to a specific candidate, like multi-candidate super PACs and party committees.
